- Reference is made to the circular dated 29 May 2025 and announcements dated 23 May 2025 and 25 June 2025 of CITIC Limited, respectively, with respect to (a) the payment of final dividend of RMB0.36 per share (equivalent to HK\$0.3941784 per share at the exchange rate of RMB1.0:HK\$1.09494) for the year ended 31 December 2024 ("2024 Final Dividend"), which will be payable in cash to each shareholder in HK Dollars and (b) the option given to the shareholders to elect to receive all (but not part) of their dividend in Renminbi ("RMB"), such dividend will be paid to you at RMB0.36 per share.

The Closing Time will be adjusted, as the case may be, in accordance with (a) or (b) below if a Typhoon Warning Signal No. 8 or above is hoisted, a Black Rainstorm Warning is in force in Hong Kong or "extreme conditions" resulting from a typhoon or a rain storm are announced by the Government of the Hong Kong Special Administrative Region of the People's Republic of China:
(a) at any local time before 12:00 noon on Thursday, 24 July 2025. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or
(b) at any local time between 12:00 noon and 4:30 p.m. on Thursday, 24 July 2025. In such a case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m.
