

Nordic Mining enters into agreements with partners for Engineering, Procurement and Construction for the Engebø project

Nordic Mining has today, through its wholly owned subsidiary Nordic Rutile AS, entered into Letters of Intent ("LOIs") with Sunnfjord Industripartner AS, Åsen & Øvrelid AS, Nordic Bulk AS, and Normatic AS as partners for Engineering, Procurement and Construction (together "EPCs") for the Engebø Rutile and Garnet project (the "Project"). The LOIs are a formalization of the EPCs deliverables toward the update of the Engebø Definitive Feasibility Study ("UDFS"), and in line with the optimized contracting and execution strategy developed to ensure the successful construction of the Project.

Sunnfjord Industripartner AS – Sitewide Earthworks and Underground Infrastructure (EPC1)

Sunnfjord Industripartner AS ("SIPA") is a company founded to compete on lager contracts for industry and communication development projects. The company has it's outspring from four local civil and earthworks companies located in Sunnfjord municipality. In preparation for construction, Nordic Mining will, together with its selected Project Management Consultant ("PMC"), and the selected EPCs partners immediately start Pre-Construction work related to setting up the Project Management Organizational Structures and Systems and selected Detailed Engineering activities.
