AFRICA OIL ANNOUNCES RESULTS OF SHARE BUYBACK PROGRAM

December 9, 2024 (AOI-TSX, AOI-Nasdaq-Stockholm) – Africa Oil Corp. (“Africa Oil”, or the “Company”) is pleased to announce that the Company repurchased a total of 815,000 Africa Oil common shares during the period of December 2, 2024 to December 6, 2024 under the two previously announced share buyback programs.

During the period dated December 2, 2024 to December 6, 2024, the Company repurchased 320,000 Africa Oil common shares on the TSX and/or alternative Canadian trading systems. The repurchases were carried out by Scotia Capital Inc. on behalf of the Company. During the same period, the Company repurchased 495,000 Africa Oil common shares on Nasdaq Stockholm, and these repurchases were carried out by Pareto Securities on behalf of the Company.

All common shares repurchased by Africa Oil under the share buyback program will be cancelled.

Africa Oil’s normal course issuer bid (share buyback) program, announced by the Company on December 4, 2023, was implemented in accordance with the Market Abuse Regulation (EU) No 596/2014 (MAR) and Commission Delegated Regulation (EU) No 2016/1052 (Safe Harbour Regulation) and the applicable rules and policies of the Toronto Stock Exchange (“TSX”), Nasdaq Stockholm, and applicable Canadian and Swedish securities laws. This share buyback program expired on December 5, 2024.

Since December 6, 2023, up to and including December 5, 2024, a total of 23,987,632 Africa Oil common shares were repurchased under this previous share repurchase program, through the facilities of the TSX, Nasdaq Stockholm and/or alternative Canadian trading systems. A maximum of 38,654,702 Africa Oil common shares could have been repurchased under the previous program.

The launch of Africa Oil’s new normal course issuer bid (share buyback) program, announced by the Company on December 4, 2024, is also being implemented in accordance with the Market Abuse Regulation (EU) No 596/2014 (MAR) and Commission Delegated Regulation (EU) No 2016/1052 (Safe Harbour Regulation) and the applicable rules and policies of the Toronto Stock Exchange (“TSX”), Nasdaq Stockholm, and applicable Canadian and Swedish securities laws.

On December 6, 2024 a total of 174,000 Africa Oil common shares were repurchased under the new share repurchase program, with 64,000 repurchased through the facilities of the TSX and/or alternative Canadian trading systems, and 110,000 repurchased through Nasdaq Stockholm. A maximum of 18,362,364 Africa Oil common shares may be repurchased under the share buyback program through the facilities of the TSX, Nasdaq Stockholm and/or alternative Canadian trading systems over the period of twelve months commencing December 6, 2024 and ending December 5, 2025, or until such earlier date as the share repurchase program is completed or terminated by the Company.

Africa Oil Corp. is a Canadian oil and gas company with producing and development assets in deepwater Nigeria, an interest in the Venus light oil and associated gas discovery, offshore Namibia, and an exploration/appraisal portfolio in west and south of Africa. The Company is listed on the Toronto Stock Exchange and on Nasdaq Stockholm under the symbol "AOI".
